ARBITRATION AWARD

- 1. The Complainant is Amazon Technologies, Inc., a company incorporated under the laws of Nevada, USA.
- The Respondent is Lubomir Kosvanec having his address at Horn Poaply 199,
 Czech Republic.
- 3. The Arbitration pertains to the disputed domain name <amazonprimevideo.in>.

 The registrar for the disputed domain name is Dynadot LLC.
- 4. The sole arbitrator appointed in this complaint by NIXI is Jayant Kumar. The Arbitrator submitted the Statement of Acceptance and Declaration of Impartiality and Independence to NIXI on March 16, 2020.
- 5. The Parties were informed about the appointment of the Sole Arbitrator by NIXI vide email dated March 19, 2020 and a physical copy of the complaint was provided to the Sole Arbitrator.
- 6. A copy of the Complaint with Annexures was served upon the Respondent.
- 7. On March 19, 2020, the Respondent sent an email to me stating that:

"i got an email that you will handling the UDRP of my domain <u>AMAZONPRIMEVIDEO.IN</u>

can you please explaine the situation to me, whats going on and who created this UDRP?"

On March 26, 2020, I sent the following email to the Respondent:

"A copy of the complaint along with annexures has been served upon you by NIXI vide email dated March 19, 2020. The complaint contains the details of the parties and the Statement of Case and reliefs sought by the Complaint. The

INDRP has been initiated by Amazon Technologies, Inc. seeking transfer of the domain name < <u>amazonprimevideo.in</u>>.

You are directed to file your Reply to the complaint by April 10, 2020 failing which you may be proceeded ex-parte. In case, you did not wish to contest the complaint, please intimate the same to the undersigned."

On March 26, 2020, the Respondent intimated its intention to not contest the matter and sent the following email:

"Do i have a chance to win this? I dont think so. And i dont want to fight with Amazon i think. What do you think? Thanks"

- 8. That no further communication or any Reply to the Complaint was received from the Respondent.
- 9. Since the Respondent is not willing to contest the matter with the Complainant, I do not find the need to pass an Award on the merits of the complaint.
- 10. In light of the aforesaid, the Arbitrator directs that the disputed domain name <amazonprimevideo.in> be transferred to the Complainant.
