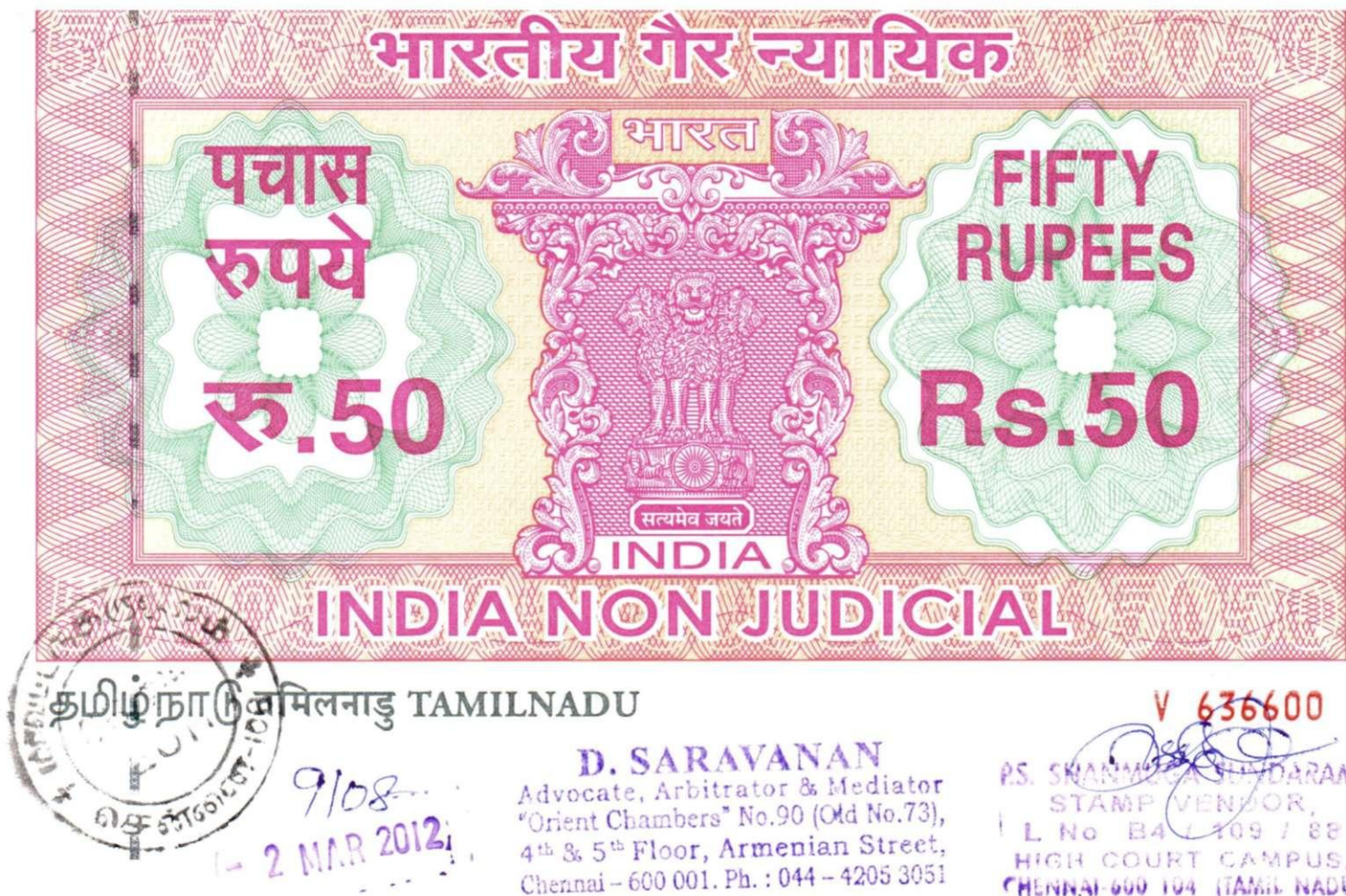

**AWARD ON AGREED TERMS MADE UNDER SECTION 30 OF THE
ARBITRATION AND CONCILIATION ACT, 1996**

1. The Parties:

The Complainant is Enterprise Holdings Inc., (Formerly Enterprise Rent-a-Car Company Inc.), 600, Corporate Park Drive, St.Louis, Missouri 63105, USA, represented by its Authorised Representative David R. Haarz.

The Respondent is Ajay Singh, T Junction Sion, Dharavi, Mumbai, Maharashtra, Pin:400006. Respondent represented himself.

2. The Domain Name and Registrar:

The disputed domain name: www.enterprisecarrental.in

The domain name registered with .IN REGISTRY

3. **Procedural History:**

- February 09, 2012 : The .IN REGISTRY appointed D.SARAVANAN as Sole Arbitrator from its panel as per paragraph 5(b) of INDRP Rules of Procedure.
- February 09, 2012 : The Arbitrator has submitted Statement of Acceptance and Declaration of Impartiality And Independence to the .IN REGISTRY.
- February 15, 2012 : The .IN REGISTRY forwarded a copy of the complaint including annexures by postal mail to the Arbitrator.
- February 18, 2012 : Arbitral proceedings were commenced by sending notice to Respondent through e-mail as per Paragraph 4(c) of INDRP Rules of Procedure, marking a copy of the same to Complainant's authorised representative and .IN REGISTRY.
- February 23, 2012 : Claimant sent an email, a copy which was marked to the Respondent stating that "*The parties have agreed upon a settlement whereby Mr. Singh will voluntarily assign the enterprisecarrental.in domain name to Enterprise Holdings, Inc. and we ask that once Mr. Singh confirms that agreement, you terminate the arbitration proceeding and enter the settlement as the decision in this matter. Your consideration in this matter is appreciated.*"
- February 23, 2012 : The Respondent sent an email stating that "*we both have agreed for a settlement regarding the domain name enterprisecarrental.in and as per that I will transfer the domain name to Enterprise Holdings, Inc*"
- February 24, 2012 : Upon the receipt of emails from the Claimant and the Respondent reporting settlement, the Arbitral Tribunal sent an email recording the settlement stating that "*The settlement reported by the Claimant which was confirmed by the respondent has been noted. I shall pass the "Settlement Award" accordingly.*"
- : The language of the proceedings in English.



Contentions:

Both the Claimant and the Respondent reported that they had arrived at a settlement amicably regarding the domain name www.enterprisecarrental.in and in terms of such settlement the Respondent had agreed to transfer the domain name www.enterprisecarrental.in to the Claimant viz., *Enterprise Holdings, Inc*

Decision:

The compromise arrived between the Claimant and the Respondent has been recorded and in accordance with the same, the Arbitral Tribunal orders that the disputed domain name www.enterprisecarrental.in be transferred to the Complainant.
