1. THE PARTIES:

The Complainant in this administrative proceeding is ER Marks, Inc., having its office at 2nd Floor Bancroft Building, 3411 Silverside Road,

Concord Plaza, Wilmington, Delaware 19810 and QVC, Inc. having its office at Studio Park, 1200 Wilson Drive, West Chester, Pennsylvania 19380, US, represented through Jeffrrey H. Epstein, Esq. and Sujata Chaudhri, Esq.

The Respondent is Stephen R. Wilson, Keyword Acquisitions, Inc. P.O. Box 952, Middleton, Massachusetts 01949, US.

THE DOMAIN NAME AND REGISTRAR

The disputed domain name <www.qvc.in> has been registered by the Respondent. The Registrar with whom the disputed domain is registered is Directi International Solutions Pvt. Ltd., dba, Publicdomainregistry.com.

3. PROCEDURAL HISTORY

- 3.1 The Complaint was filed with the .In Registry, National Internet Exchange of India (NIXI), against Stephen R. Wilson, Keyword Acquisitions, Inc. P.O. Box 952, Middleton, Massachusetts 01949, US. The NIXI verified that the Complaint together with the annexures to the Complaint and satisfied the formal requirements of the .in Domain Name Dispute Resolution Policy ("The Policy") and the Rules of Procedure ("The Rules").
- 3.2 In accordance with the Rules, Paragraph-2(a) and 4(a), NIXI formally notified the Respondent of the Complaint and appointed me as a Sole Arbitrator for adjudicating upon the dispute in accordance with The Arbitration and Conciliation Act, 1996, Rules framed there under. In Dispute Resolution Policy and Rules framed there under on 3rd February, 2012. The parties were notified about the appointment of an Arbitrator on 3rd February, 2012.
- 3.3 The Panel has submitted the Statement of Acceptance and Declaration of Impartiality and Independence, as required by NIXI to ensure compliance with the Rules (paragraph-6). The arbitration proceedings commenced on 3rd February, 2012. In accordance with the rules, paragraph 5(c). The Respondent was notified by me

about the commencement of arbitration proceedings and the due date for filing his response.

- 3.4 The respondent by his e-mail dated 05th February, 2012 intimated the panel that he has not received a copy of the complaint from .in registry and submitted that he has learned about the dispute for the first time when the Registrar (Directi) informed him few days ago. He further requested the panel to forward the copy of the complaint filed by the complainant.
- 3.5 The panel by his e-mail dated 06th February, 2012 directed the complainant to send the soft copy of the complaint along with all the annexures to the respondent within 3 business days of the notice.
- 3.6 The complainant and the respondent started negotiating between themselves the dispute relating to the domain name <qvc.in>.
- 4. The complainant's attorneys by their e-mail dated 18th February, 2012 intimated the respondent that their client is not interested in terminating the proceedings since that might not guarantee the transfer of the impugned domain name and decided to contest the present proceedings.
- 5. The respondent by his e-mail dated 22nd February, 2012 intimated the panel that they have attempted on a couple of occasions to transfer the domain name voluntarily to the complainant but the opposite counsel suggested that the panel should effectuate the voluntary transfer.
- The respondent further submitted that he has decided not to oppose the present complaint.



7. DECISION

In view of the fact that the respondent does not dispute the proprietary rights of the complainants in the impugned Domain Name and do not oppose the relief as prayed by the complainant, Panel under the said facts and circumstances direct the respondent to transfer the impugned domain name <www.qvc.in> to the complainant.
