

ARBITRATION AWARD

- 1. The Complainant is Dell Inc., a Delaware Corporation having its registered office at One Dell Way, Round Rock, Teexas 78682-2244, USA.
- The Respondent is Yuvraj Jadon having his address at Sabalgarh, Sunehara, Madhya Pradesh, India and at Yashwant Plaza, Near Railway Station, Indore, Madhya Pradesh, India.
- 3. The Arbitration pertains to the disputed domain name dellaptopservicecenterindore.in. The registrar for the disputed domain name is Godaddy.com, LLC.
- 4. The sole arbitrator appointed in this complaint by NIXI is Jayant Kumar. The Arbitrator submitted the Statement of Acceptance and Declaration of Impartiality and Independence to NIXI on April 18, 2018.
- 5. The Parties were informed about the appointment of the Sole Arbitrator by NIXI vide email dated May 4, 2018 and a physical copy of the complaint was provided to the Sole Arbitrator.
- 6. On May 6, 2018, the Respondent sent an email stating that:

"On the basis of this mail. i have got to know that this is the disputed domain, So i do not want to retain it at my end. So you are requested to take its ownership."

7. On May 22, 2018, taking cognizance of the aforesaid email, the Arbitrator decided to pass a consent award based upon the aforesaid email of the Respondent and sent an email to the parties stating that a consent award will be

passed on the basis of the aforesaid email and the Respondent can file clarification/objection, if any, within three days viz. May 25, 2018.

- 8. That no further communication was received from the Respondent.
- 9. Since the Respondent is willing to surrender/transfer the domain name in favour of the Complainant, the Arbitrator does not find the need to pass an Award on the merits of the complaint.
- 10. In light of the aforesaid, the Arbitrator directs that the disputed domain name dellaptopservicecenterindore.in be transferred to the Complainant.
