2. DOMAIN NAME AND TRADEMARK IN DISPUTE:

Domain name of the respondent is "www.cipriani.in"

The trademark of the complainant is "CIPRIANI". The registry is National Internet Exchange of India (NIXI).

3. BRIEF BACKGROUND:

This arbitral proceeding commenced in accordance with IN Dispute Resolution Policy (INDRP) and rules framed thereunder.

The complainant submitted his complaint in the registry of NIXI. Shri Sanjay Kumar Singh was appointed as Sole Arbitrator in the matter by NIXI. The complainant has submitted that the disputed domain name is identical and deceptively similar to the domain name and trademarks of the complainant.

The complainant has submitted that Hotel Cipriani S.p.A is the proprietor of one of the most prestigious hotels in the world. The complainant has its roots back in the year 1956 when it was established by Mr. Giuseppe Cipriani along with others. In 1958, the Hotel bearing the name CIPRIANI opened to the public. Today, HOTEL CIPRIANI, is considered as one of the finest luxury accommodations in the world. The complainant has annexed the brochure of Hotel CIPRIANI has been annexed by complainant as Annexure-A.

The complainant has further submitted that it is registered proprietor of the marks CIPRIANI having the below details:

The complainant has also submitted that respondent lacks or has no rights or legitimate interests in respect of the disputed domain name that is the subject of the complainant.

The complainant has further submitted that the disputed domain name was registered in bad faith.

The complainant as such has prayed for an award in the above matter for transfer of the domain name "www.cipriani.in" in favour of the complainant.

ARBITRAL PROCEEDINGS & AWARD:

A copy of complaint has already been sent to the respondent by the .In Registry through e-mail.

Upon receipt of the complaint, the Arbitrator sent a notice dated 23-11-2019 to the respondent to send the defense / counter to the complaint along with supportive documents / evidence at his e-mail address within 10 days from receipt of notice. But the respondent did not come forward and did not send any defense / counter or reply to the complaint.

The respondent replied vide an email dated 02-12-2019 from the e-mail ID of the respondent stating that "Apologies as I was unaware regarding Cipriani.com. I fact I was developing my website Cipriani.in.

Kindly let me know how to proceed in transferring the domain

The arbitrator informed the respondent vide email dated 02-12-2019 to send the reply whether the respondent intends to transfer the domain name "cipriani.in" to the complainant.

The arbitrator vide email dated 03-12-2019 further directed the respondent to submit the reply / response to the complaint of the complainant within FIVE days positively from receipt of the notice failing which the complaint shall be decided on the merit of the complaint and as per law of the land. θ

Sengrar par Lyl. 16/12/2019 The Respondent sent an email dated 05-12-2019 wherein the respondent has stated that the respondent intends to transfer the domain "www.cipriani.in" to the Complainant.

The email of the Respondent dated 05-12-2019 is reproduced below:

"Dear Mr Singh,

Yes I intend to transfer the domain name "cipriani.in" to the complainant. However, I would like to know:

- 1. The procedure
- 2. The implications

As per the call made by Fidus law yesterday to me, they have stated that the transfer only requires a letter stating the same and that there are no legal implications or any other.

The respondent has not filed any reply or documents despite of notices and opportunities. Therefore, this matter is being decided in view of the email of the respondent dated 02-12-2019 & 05-12-2019 sent from the email ID of the respondent and as per law of the land. The contents of email of the respondent dated 02-12-2019 & 05-12-2019 from the email ID hridaytulsiani@gmail.com are reproduced hereinabove.

It has been held Apex court in Indian decision M/s Satyam Infoway Ltd. Vs. M/s Siftynet Solution (P) Ltd. JT. 2004 (5) SC 541, that Domain name has all characteristics of trademark. As such principles applicable to trademark are applicable to domain names also. In the said case the words, "Sify' & 'Siffy' were held to be phonetically similar and addition of work 'net' in one of them would not make them dissimilar.

4. FINDINGS

After going through the submission of the complainant, the law of the land and considering the email of the respondent dated 02-12-2019 & 05-12-2019

sent from the e-mail ID of the respondent, the conclusion is that the

respondent has got registered his domain name "www.cipriani.in" in bad

faith and the respondent has no right or legitimate interest in the domain

name.

In above facts and circumstances the complainant has established the right

over the above domain name "www.cipriani.in".

5. <u>CONCLUSION:</u>

The domain name "www.cipriani.in" of the respondent is identical and

confusingly similar to trademark of complainant. The respondent also does

not have right or legitimate interest in the domain name. The respondent

has got it registered in bad faith; as such respondent is not entitled to retain

the domain name. The complainant is entitled to transfer of domain name

"www.cipriani.in" as the complainant has established the bonafide rights

in trademark and in view of the email of the respondent dated 02-12-2019 &

05-12-2019 sent from the e-mail ID of the respondent. The complainant is

entitled to transfer of domain name "www.cipriani.in". Hence I direct that

the Domain name be transferred to the complainant by registry.
