



#### The Parties

The **First Complainant** in this arbitration proceeding is *Masonite Corporation*, a company incorporated under the laws of Delaware. The **Second Complainant** is *Masonite International Corporation* that is the parent company of Masonite Corporation and incorporated under the laws of British Columbia, Canada. Masonite International Corporation has its registered office at 2771 Rutherford Road, Concord, Ontario, Canada — L4K2N6. Masonite Corporation has its registered office at One Tampa City Center, 201 N. Franklin St., Tampa, Florida, USA 33602

The **Respondent** in this arbitration proceeding is *Media2K Group*, located at 1679 S. Dupont Hwy, Suite 100, Dover, Delaware, USA 19901 as per the details given by the Whois database maintained by the National Internet Exchange of India [NIXI].

### The Domain Name and Registrar

The disputed Domain name is <u>www.masonite.in</u>. The Registrar with which the disputed domain name is registered is *Name.Com LLC. (R65- AFIN)* 

# Procedural History [Arbitration Proceedings]

This arbitration proceeding is in accordance with the .IN Domain Name Dispute Resolution Policy [INDRP], adopted by the National Internet Exchange of India ["NIXI"]. The INDRP Rules of Procedure [the Rules] were approved by NIXI on 28<sup>th</sup> June 2005 in accordance with the Indian Arbitration and Conciliation Act, 1996. By registering the disputed domain name with the NIXI accredited Registrar, the Respondent agreed to the resolution of the disputes pursuant to the IN Dispute Resolution Policy and Rules framed there under.

According to the information provided by the National Internet Exchange of India ["NIXI"], the history of this proceeding is as follows:

In accordance with the Rules, 2(a) and 4(a), NIXI formally notified the Respondent of the Complaint, and appointed James Mukkattukavunkal as the Sole Arbitrator for adjudicating upon the dispute in accordance with the Arbitration and Conciliation Act, 1996, and the Rules framed there under, .IN Domain Name Dispute Resolution Policy and the Rules framed there under. The Arbitrator submitted the Statement of Acceptance and Declaration of Impartiality and Independence, as required by NIXI.

The request for submission with a complete set of documents was dispatched to the Respondent by the Arbitrator on 17<sup>th</sup> May, 2017. Electronic copy of the complete set of documents was also sent to the Respondent by mail on 28<sup>th</sup> April, 2017. The Respondent was requested to send in all such documents by 5<sup>th</sup> June, 2017. The Respondent vide mail dated 24<sup>th</sup> May, 2017 has communicated to the panel that it does not wish to contest the matter and is willing to transfer the domain name to the Complainant.

### Decision

In light of the Respondent's decision in not contesting the matter in regard to the disputed domain name and in accordance with Policy and Rules, the Panel directs that the disputed domain name [www.masonite.in] be transferred from the Respondent to the Complainant; with a request to NIXI to monitor the transfer.
