	a final extension of three (3) days to respond to the complaint.
January 31, 2025	Respondent's Counsel filed a reply.
February 03, 2025	In view of the reply submitted by the Respondent on January 31, 2025,
	Complainant's was granted a time of ten (10) days to furnish a
	rebuttal/rejoinder.
February 11, 2025	Complainant's Counsel formally withdraws the domain complaint,
