#### AWARD

#### 1. The Parties:

The Complainant is **Indiagames Limited**, Vishwaroop IT Park, Vashi International Info-tech Park, Above Raghuleela Mall, 11<sup>th</sup> Floor, Plot No.34, 35 & 38, Sector-30A, CIDCO Vashi, Navi Mumbai-400705, Maharashtra, India. The Complainant is signed by its authorized representative Mr. Manav Kumar of Saikrishna & Associates, A-2E, CMA Tower, 2<sup>nd</sup> Floor Sector-24, Noida – 201301, Uttar Pradesh, India who have submitted complaint against the domain. ### 2. The domain name, Registrar & Registrant:

The disputed domain name is <a href="www.tadkalive.in">www.tadkalive.in</a>. The Registrar is Directi Web Services

#### 3. Procedural History:

The Complainant filed this complaint with the .IN Registry and the .IN Registry appointed "Ranjan Narula" ("The Arbitrator") as the Sole Arbitrator under clause 5 of its policy on 01<sup>st</sup> August 2012, the Arbitrator filed its declaration of impartiality and independence on 06<sup>th</sup> August 2012. The Complaint and annexures were received by Arbitrator from NIXI on 16<sup>th</sup> August 2012. The notice was issued to the Respondent on August 17, 2012 at his email address with a deadline of 10 days to submit his reply. The Respondent filed his response vide email dated August 28, 2012 essentially agreeing to transfer the domain name. On August 29, 2012 the Arbitrator provided opportunity to Complainant to comment on the Respondent's proposal. The Complainant by his response on August 30, 2012 agreed to Respondent's offer and prayed for transfer to domain name <www.tadkalive.in>.

### 4. Discussions & Findings

As both parties have agreed to resolve the matter amicably with Respondent agreeing to transfer the domain name and the complainant agreeing to the proposal, thus the primary purpose of filing this complaint and relief sought for by the Complainant has been voluntarily agreed by the Respondent. In the circumstances

the Arbitrator sees no real need to go into the merits of the contentions raised by the Complainant and documents filed in support.

## 5. Decision

For the reasons discussed above, the Arbitrator orders that the domain name <www.tadkalive.in> be transferred to complainant. Parties to bear their own cost.
