1. The Parties:

The Complainant is Tata Motors Limited, 24 Homi Mody Street, Fort, Mumbai – 400 001, State of Maharashtra, India, represented by its Authorised Representative Ms.Malavika T.Vikram of M/s DePenning & DePenning, No.120, Velachery Main Road, Guindy, Chennai 600 032, India.

2. The Domain Name and Registrar:

The disputed domain name is < www.TATATIGOR.co.in >. The domain name has been registered with .IN REGISTRY.



3. DISPUTE AND RELIEF SOUGHT FOR:

The complaint has been filed seeking a remedy to issue a decision that the ownership in www.tatatigor.co.in be transferred to the complainant on the grounds inter-alia that the registration of the disputed domain name by the respondent is identically or confusingly similar in which the complainant has rights; the respondent has no rights or legitimate interest in respect of the disputed domain name; and the said domain name was registered and is being used in bad faith.

4. PROCEDURAL HISTORY:

May 17, 2017 : Date of Complaint.

June 05, 2017 : The .IN REGISTRY appointed D.SARAVANAN

as Sole Arbitrator from its panel as per

paragraph 5(b) of INDRP Rules of Procedure.

June 05, 2017 : Consent of the Arbitrator was given to the .IN

REGISTRY according to the INDRP Rules of Procedure along with the Statement of Declaration of impartiality and independence.

June 05, 2017 : .IN REGISTRY sent an email to all the

concerned intimating the appointment of

arbitrator.

June 05, 2017 : NIXI sent the soft copy of the complaint

and annexure to the respondent marking a copy of the same to all the concerned. The same was also sent by Speed Post to the respondent vide receipt No.RD730743023IN.

respondent vide receipt No.No7307 130231N.

June 07, 2017 : Email was sent by the respondent stating that

they would be happy to transfer the domain

name to the complainant.

June 07, 2017 : Email was sent by the Arbitral Tribunal seeking

assertion of the respondent regarding their

"No Objection".



June 07, 2017

Email was sent by the Respondent confirming

their "No Objection".

June 07, 2017

Email was sent by the Arbitral Tribunal to all

the concerned stating that the Award will be passed based on the consent of the

Respondent.

5. NO OBJECTION OF THE RESPONDENT:

The respondent had sent an email on 06.06.2017 stating that they would be happy to transfer the domain name to the Complainant and had also sent another email on 07.06.2017 asserting their 'No Objection'.

6. DECISION:

In the light of the 'No Objection' from the respondent and in accordance with Paragraph 10 of the Policy, the Arbitral Tribunal orders that the disputed domain name **<www.TATATIGOR.co.in>** be transferred to the Complainant.
